APPLICANTS WILL RECEIVE EITHER A REQUEST FOR ORDERS (RFO) OR OFFICIAL NOTIFICATION WITH INSTRUCTIONS FROM THE HUMAN RESOURCES COMMAND (HRC) WITHIN 90 DAYS. THESE INDIVIDUALS MUST HAVE SECURITY CLEARANCE VERIFICATION WHEN THEY REPORT TO FORT RUCKER FOR WOCS. THESE INDIVIDUALS MUST ALSO HAVE A QUALIFIED COMMISSIONING OR CLASS 1 FLIGHT PHYSICAL (WITH NO DISQUALIFYING MEDICAL CONDITION IAW AR 40-501) AND WILL ENSURE THEIR PHYSICAL IS CURRENT AND EXTENDS THROUGH THEIR SCHEDULED WOCS ATTENDANCE. CANDIDATES POSSESSING PHYSICALS THAT DO NOT COVER COMPLETE ATTENDANCE THROUGH WOCS MAY RESULT IN DENIED ENROLLMENT.
